Unfinished Business:

- 1. Dyce has responded to prior requests from Homeowner Jim Gates concerning garbage cans at 1221 Reserve. Dyce has spoken to the owner and they will make sure to place cans inside of their garage. They also informed Dyce that they will be moving soon, so this should no longer be an issue.
- 2. From the December HOA meeting, it was brought to the boards attention the sidewalk between 1255 and 1261 Reserve was uneven and a possible hazard. Dyce examined the area and decided when the weather is warmer that "mud jacking" will be needed below the affected sidewalk.
- 3. Another issue brought during the December HOA was the light on the 17th entrance sign. Dyce has checked the sensors and they all appear to be working correctly now.
- 4. The new homeowner's directory is done and has been distributed.
- 5. Bylaws need to be reviewed to see if there are restrictions on any remaining income that was not used during the calendar year. If there are no restrictions then this money can be rolled into the reserve account.
- 6. Sabrina will look into finding out exactly who is responsible for maintaining the fence along the homes that back up to the golf course.
- 7. Dyce will repair a piece of broken fence along the 17th side of the Reserve.
- 8. Suggestion to present costs of fences during the summer meeting.
- 9. Landscaping contract is due in March.
- 10. Improvement grant was submitted by Bob and Sabrina Lee. The grant is requesting the amount of \$5,000 for trees to be planted along 17th avenue.

New Business:

1. Snow Removal was done late at night during December. Dyce witnessed the city maintenance crew plowing the public sidewalk and turning around through the HOA's landscaping. Dyce spoke with Bill at Parks and Recreation. Dyce walked the area with Bill to show him the tracks through the grass. It is now recorded with the city, in case of sprinkler damage.

- 2. The west side of the sidewalk/grass area along 17th also appeared to show damage from a snow removal vehicle. It appears to be the work from Wards who removes snow for the apartment complex.
- 3. Wade presented the financials for the year ending December 2011. (see attached) He also informed us the Reserve CD is currently at First Bank and will look at rates at Guarantee Bank where the checking account is located. Sabrina will also check the credit union to see what the rates are there.

- 5. Wade has sent out the HOA Dues statement. He delivered 2/3 of them personally and mailed the rest. He will send a reminder later in the month to those he has not received payment from

Reports of Board Members:

- 1. Minutes were read from the June Meeting. Wade approved and Sabrina seconded the approval.
- 2. Dyce Landscaping –

Small problem areas in the SW corner of the subdivision have been evaluated by Dyce and Rock Solid. They have determined that the timers are maxed out. Other issues are that landscaping (i.e. trees/bushes) are obstructing sprinkler heads. This is an issue in many areas of the common area along the west side of the development. To make the sprinklers more efficient, suggestions to remove lower branches off many of the trees and to trim bushes would help this issue.

Spot weed treatment has been done twice by the common area around the Lang's home. This area has improved since the May walk through. Harvey Lang still continues to email the board with issues of weeds. It is suggested that he attend a meeting so Dyce can go over everything that has been done, and explain what Rock Solid has done in person rather than through emails.

Rock Solid skipped mowing the first week of July and will give us a credit or additional mowing in the fall. With the record temperatures for the month of June, leaving the lawn a little longer should help maintain the moisture and keep the lawn greener.

Dyce works continuously with Rock Solid and communicating with them to help improve our common areas.

- Wade No additional dues/fees collected this past month. The title company for the sale of 1221 Reserve did not collect HOA dues during the closing. Wade is working with them to make sure they will be collected. An Accounts Receivable schedule will be made to show the outstanding dues/fees.
- 4. Kelly We received the grant from Longmont for \$150 towards a neighborhood picnic.
